

## JACKPOT.COM SUPER TUESDAY SUMMER SWEEPSTAKES (THE “SWEEPSTAKES”)

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE ENTRY PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

**ELIGIBILITY:** The Sweepstakes is open only to legal residents of the States where Lottomatrix Corporation d/b/a Jackpot.com (“Jackpot.com”) operates at the time of the sweepstakes Entry Period (currently New York, Ohio, Massachusetts, New Jersey, Arkansas, Colorado, and Arizona) (the “**Eligible Territory**”) who are eighteen (18) years of age or older at the time of entry (21 or older in Arizona). Entry is limited to Jackpot.com customers who redeem the ‘Super Tuesday’ promotion each week during the Entry Period defined below (available on Tuesdays from 12:00 a.m. until 11:59 p.m.) or submit a free entry. Limit one (1) entry per Jackpot.com account holder, regardless of method of entry, per week. You can enter the drawing the two ways described below:

**SUPER TUESDAY REDEMPTION:** Any redemption of the ‘Super Tuesday’ promotion during the Entry Period on Tuesday between 12:00 a.m. and 11:59 p.m. by a customer who is a resident in the Eligible Territory will qualify as an entry for the duration of the sweepstakes. To enter you must login to your Jackpot.com account on any Tuesday during the promotion period, navigate to the promotions tab, claim the promotion, redeem the promotion and make a purchase with promotion applied. If you do not have a Jackpot.com account, you must first register for an account by clicking the “sign up” button and following the on-screen prompts to create a new account. Account creation is free and requires that you provide your name, address, phone number, email address and date of birth. **FREE ENTRY:** To enter without any purchase, go to <https://www.jackpot.com/super-tuesdays-summer-sweepstakes-form> and fill out the form located there with the following information: full name, mailing address and the email address you used to create your Jackpot.com account. **IMPORTANT:** The first name, last name, email address and zip code that you enter in the form **MUST EACH** match the first name, last name, email address and zip code, respectively, that you used to create your Jackpot.com account. If the first name, last name, email address and zip code do not **ALL** match, then you will not receive any Entries for this Sweepstake’s Drawing. Upon successful completion of the form, you do not need to make any purchase from your account in order to enter for this Sweepstakes during the Entry Period and receive an entry in the Drawing. Creating a Jackpot.com account is free. Limit 1 Free entry per Customer during the Entry Period. The weekly prize for the Free Entry will run from 12:00a.m. on Tuesday each week until 11:59 p.m. the following Monday during the Entry Period at which time it changes to the following week’s prize.
