

**JACKPOT.COM SUPER TUESDAY JACKPOT REWARDS SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE ENTRY PERIOD. VOID WHERE PROHIBITED BY LAW. ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The Super Tuesday Jackpot Rewards Sweepstakes is open only to legal residents of the States where Lottomatrix Corporation d/b/a Jackpot.com ("[Jackpot.com](https://www.jackpot.com)") operates at the time of the sweepstakes Entry Period and where Jackpot Rewards is available (currently Ohio, Massachusetts, Arkansas, Colorado, and Arizona) (the "**Eligible Territory**") who are eighteen (18) years of age or older at the time of entry (21 or older in Arizona). Entry is limited to [Jackpot.com](https://www.jackpot.com) customers who redeem the 'Super Tuesday' promotion each week and are opted into Jackpot Rewards during the Entry Period defined below (available on Tuesdays from 12:00 a.m. until 11:59 p.m.) or submit a free entry. The Sweepstakes is subject to all applicable laws, rules, and regulations. Void outside the Eligible Territory and where prohibited or restricted by law, rule, or regulation.

HOW TO ENTER: The Sweepstakes entry period begins on 5/12/26 and ends on 6/2/26 ("**Entry Period**"). You may enter the Sweepstakes by redeeming the 'Super Tuesday' promotion via the promotions tab each week on the [Jackpot.com](https://www.jackpot.com) mobile application and confirming you're opted into Jackpot Rewards or by utilizing the free entry form. Limit one (1) entry per [Jackpot.com](https://www.jackpot.com) account holder, regardless of method of entry, per week. You can enter the drawing the two ways described below:

SUPER TUESDAY REDEMPTION & LOYALTY OPT-IN: Any redemption of the 'Super Tuesday' promotion during the Entry Period on Tuesday between 12:00 a.m. and 11:59 p.m. by a customer who is opted into Jackpot rewards and is a resident in the Eligible Territory will qualify as an entry for the duration of the sweepstakes. To enter you must login to your [Jackpot.com](https://www.jackpot.com) account on any Tuesday during the promotion period, navigate to the promotions tab, claim the promotion, redeem the promotion and make a purchase with promotion applied. If you do not have a [Jackpot.com](https://www.jackpot.com) account, you must first register for an account by clicking the "sign up" button and following the on-screen prompts to create a new account. Account creation is free and requires that you provide your name, address, phone number, email address and date of birth. You can close your account at any time, however, to remain eligible for the Sweepstakes you must keep your account open at least through the Drawing Date (as defined below). If you are not opted into Jackpot rewards, you must opt in by going into settings, clicking the "Loyalty" tab and following the on-screen prompts to opt in. Upon completion of an order, you will receive one (1) entry into the sweepstakes. Every week during the Entry Period when a new Super Tuesday promotion comes available you may enter again for the new prize.

FREE ENTRY: To enter without any purchase, go to <https://www.jackpot.com/super-tuesdays-jackpotrewards-sweepstakes-form> and fill out the form located there with the following information: full name and the email address you

used to create your Jackpot.com account. **IMPORTANT:** The first name, last name, and email address that you enter in the form **MUST EACH** match the first name, last name and email address respectively, that you used to create your Jackpot.com account. If the first name, last name, and email address do not **ALL** match, then you will not receive any Entries for this Sweepstake's Drawing. Upon successful completion of the form, you do not need to make any purchase from your account in order to enter for this Sweepstakes during the Entry Period and receive an entry in the Drawing. Creating a Jackpot.com account is free. Limit 1 Free entry per Customer during the Entry Period. The weekly prize for the Free Entry will run from 12:00a.m. on Tuesday each week until 11:59 p.m. the following Monday during the Entry Period at which time it changes to the following week's prize.

RANDOM DRAWING; ODDS: Following the conclusion of each week during the Entry Period with the winner's announcement being made no later than the subsequent Friday ("**Drawing Date**"), the winner(s) will be selected each week by random drawing from among all eligible entries received. Subject to verification of eligibility and compliance with these Official Rules, the weekly winner(s) will be declared the official winner(s) of the Sweepstakes for that week. Odds of winning depend on the total number of eligible entries received during the Entry Period and the total numbers of winners eligible for the prize.

PRIZE: Prizes will be awarded on each Drawing Date for the following eligible dates in the Entry Period as follows:

For New Jersey residents, the limitations set forth above may be inapplicable where attorneys' fees, court costs, or other damages are mandated by statute. These Official Rules shall be governed by and construed and interpreted in accordance with the laws of the State of Delaware, U.S.A, applicable to contracts entered into and performed exclusively in that State.
